If you decide to mail in your bond rather than go to the office, MAIL MONEY ORDER, CASHIER'S CHECK OR CERTIFIED CHECK DIRECTLY TO THE TRIAL COURT OFFICE BEFORE WHOM YOU ARE SUMMONED TO APPEAR. The trial court name and address shown on The front side of this summons. DO NOT MAIL CASH OR PERSONAL CHECK. Be sure to enclose with the bond the arresting officer's name and the summons number.
- if a court appearance is not mandatory, you may pay your fine online with a credit card for citations issued in participating counties. Go to http://sc.gov/OnlineServices/Pages/CourtPayments.aspx to determine if online payments are available in the county the citation was issued.
- You may appear in court on the assigned date and time and have a trial conducted by the Trial Judge.

THE POSTING OF BOND BEFORE YOUR ASSIGNED TRIAL DATE IN NO WAY AFFECTS YOUR RIGHT TO HAVE A FAIR TRIAL BY THE JUDGE OR, IF YOU MAKE A WRITTEN REQUEST BEFORE YOUR SCHEDULED TRIAL BY JURY.

However, if you are NOT required to appear in court on the assigned trial date and have previously posted bond and do not appear on the trial date, your bond may be forfeited unless the judge has agreed to have your case heard at another time.



When I looked inside the pickup truck, I observed a side airbag deployed, a seatbelt that was tightened to the b column thus demonstrating the driver was not wearing his seatbelt at the time of the collision. I also observed more beers and containers of alcohol in the vehicle. Trooper B.R.Hyatt arrived on scene and stood by for the tow truck and I went to McLeod ER to identify and speak with the driver.

When I arrived at McLeod ER, I asked Mr. Turner if he was involved in a collision in an attempt to avoid asking the desk attendant in which he stated he was not. The nurse then advised Mr. Turner in fact was involved in an accident and had been brought by EMS from my collision scene. When I went back in the room I asked Mr. Turner why he said he wasn't in an accident which he stated he didn't know why he said that, I asked his name and what happened. He immediately told me he was not going to give me his name and he wanted a lawyer. At this time he was not under arrest and I advised him he needed to give me his name and just tell me what happened. He agreed to give me his name and date of birth and told me

he didn't remember what happened. He identified himself a Bo Turner. While speaking with Mr. Turner I noticed he had a very strong odor of alcohol coming off of his persons, I asked him if he would be willing to participate in field sobriety test and he agreed. I had reasonable suspicion to believe he may be under the influence based on his odor, multiple alcohol containers in and around his vehicle as well as his slurred /slowed speech and his repetitive mannerisms. The doctor advised at this time it would best for him to remain seated due to possible injuries to his head, neck or spine.

While seated I instructed Mr. Turner through an HGN test after clarifying he had no medical conditions and did not wear glasses. While performing HGN Mr. Turner showed lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation and onset nystagmus prior to 45 degrees. He also displayed Vertical gaze nystagmus. Because of his possible injury I could not proceed with the 9 step walk and turn or the one legged stand. Mr. Turner was given the ABC test which he was instructed to verbally say the alphabet starting with the letter E and stopping at the letter T. Mr. Turner verbalized the entire alphabet from A-Z, I repeated the instructions for clarification and Mr. Turner did the same thing a second time. I then conducted a Finger dexterity test and instructed Mr. Turner to touch the thumb of the selected hand and touch each fingertip starting with the index finger and moving toward the pinky finger counting out loud 1,2,3,4 each time his thumb touches a finger. When he touches his pinky he must immediately execute the test in reverse. Mr. Turner failed to follow instructions on executing the test and could not touch the corresponding fingers to number forward or backward.

At this time I had determined Mr. Turner was under the influence of alcohol or drugs and placed him under arrest and gave him his Miranda rights. When I told him he was under arrest he responded with, you cannot arrest me and I'm not going to jail, I asked a nurse if she could get security to come to the room because of the statement made by Mr. Turner. He took off his neck collar and began trying to leave while screaming, using profane language while suspected to be under the influence and being disorderly. I did not attempt to handcuff Mr. Turner at this time due to the possibility of injury he had not been cleared from yet, he stated he had to urine and I closed the curtain to give him privacy, when I opened the curtain a few moments later Mr. Turner was attempting to unlock a door to leave the hospital room he was in. At this time the doctor stated his CT scans had come back clear and he there was no evidence of a head injury. I told Mr. Turner he was under arrest a second time and advised him to turn around and put his hands behind his back and he refused to, I asked him a second time and he said no. Myself and a McLeod security officer grabbed Mr. Turner by his arms and instructed him to bring his hands to the small of his back in which he continued to tighten up and resist. He was then overpowered and placed into handcuffs by me and the officer.

We then carried Mr. Turner to my patrol car to transport him to the Florence county detention center. While in route to the detention center he called me slurs and continuously stated he was being arrested for no reason as well as assumed I had a personal vendetta against him. Due to his behavior at the hospital and random bursts of anger while in my patrol car I requested deputies meet me at the jail to deescalate the situation as quickly as possible. When I arrived he was taken into the BA room at the county jail where Mr. Turner continued uttering profanity as well as sizing up the other officers, vocalizing if he wasn't in handcuffs things would be different. I attempted to loosen Mr. Turner's handcuffs after many complaints and he immediately pulled his hand back and stated he hasn't been arrested so he doesn't have to give it back, the detention officer assisted me with grabbing his hand back and placing the handcuff back on his wrists. Mr. Turner was told to remain seated and had to be placed back in the chair numerous times when instructed.

I read Mr. Turner his implied consent rights and gave him to opportunity to give me a breath sample which he imitated blowing into but would not blow hard enough to have his breath read by the machine after correcting him twice thus being

marked as a refusal. Mr. Turner was then taken into booking where he had to be placed into a safety restraint chair for his safety and the safety of others. I charged Mr. Turner with DUI 1st offense, open container of liquor/beer in a motor vehicle, driving without a seatbelt, public disorderly and resisting arrest.
