

On 12/5/19 at approximately 2121 hrs, while at the 600 block of Colleton St, which is in the City of Columbia, County of Richland, aff conducted a lawful traffic stop of a gray 2015 Honda Accord for not having any operating tail lights. During the traffic stop aff observed, in plain view on the passenger seat, a clear plastic bag containing approximately 55 multi-colored pills which field tested presumptive for MDMA. During a probable cause search of the vehicle a Newport cigarette box was located on the driver seat, which contained a white rock like substance with an approximate field weight of 2 grams, which field tested presumptive for Cocaine Base. Found on the def during a search of his person was a plastic bag with a field weight of approximately 20 grams of green plant material consistent with marijuana.
