[00:00:00] **Mandy Matney:** Hello. I have never been more happy to say this phrase but it is a good day for Justice. Alex Murdaugh has finally been held accountable for his actions. He will spend the rest of his life in prison for what he did to Maggie and what he did to Paul on June 7th, 2021. And I cannot say this enough: that is a big deal. We've said this a lot but this was never just a murder case. We wanted justice for Maggie and Paul. We also wanted justice for the South Carolina justice system to show that it had the resolve to go up against money and power. Too often, people like Alex Murdaugh have been able to use their influence to talk their way out of crimes they are suspected of committing. Over time, they have effectively created their own justice system, one largely reserved for wealthy white men. After Alex was sentenced Friday, Liz, Eric, and I went back to the Justice Mobile in Walterboro to talk about everything we were feeling and thinking about the trial. The last 48 hours before the trial ended were such an emotional rollercoaster for all of us. I really wanted to share with y'all what it was like in the final moments before we packed up and left Walterboro. So, today's episode is a little different. It's basically a raw version of the three of us just hanging out and taking it all in. At the end of the episode, you'll hear us get a visit from Scott Grooms, the city of Walterboro's director of tourism in downtown who served as a court liaison to the media, and he stopped by to say goodbye. This conversation got emotional. There were tears from all three of us but we all did our best to keep it together. I am so excited to share this episode with you so let's get into it.

I felt like we knew so much more at times than even Dick or the prosecution knew in a way because we were able to filter it to really and distill it to good hard evidence. And, you know, we've made a lot of forecasting and certainly over the last month I got on TV and every day I'm like, "I think the prosecution's done amazing." "I think Creighton had a great cross" or "Savannah did a great job."

They think that today, he's more they believe in his innocence more than they did yesterday. Oh, and John Meadors' closing argument where he said that Paul testified by his recording so it was an insurance policy that his dad wouldn't lie against him about being in the kennels. It's a problem because it's not only that the jury told them that they were wrong. Not only and we'll talk about Judge Newman's sentencing the way that he almost took off his robe and talked to him man to man like a man would talk to another man. But I have not met in the last six weeks not one person who has said Alex is innocent. Met a lot of people that said, "I believe he did it but I don't believe the government is meeting their burden." And that's fine. That's an intellectually honest opinion. But how is it that Dick, Jim, and that table and then just Lynn, John Marvin, and Buster — I don't know about Randolph because he wasn't at the trial enough, which makes me believe that either he had some questions or was worried about the visual of him being there.

But I think people feel like it's Diet Coke as opposed to full Coke; that they look at direct evidence being a Coke and somehow circumstantial evidence is Diet Coke kind of in a way.

[00:08:24] **Eric Bland:** You could. You would. But appellate court judges, don't forget, appellate court judges are parents and they're people too and they wanna see some humanity. And the decisions that have been made by Dick and Jim at that sentencing were mind-numbing to me.

I lied to you and I'm gonna have to live with that." Something to humanize. But he was strident. "I am innocent." And judge gave him a number of chances to say, well, do you wanna say anything else? And then you saw the judge take off his robe and become a lawyer and say, "You disgrace my profession. You lied. You stole. You took an oath. You were in a position of power and prominence and you abused it and you were a law enforcement officer. And oh, by the way, I don't like how you tore into law enforcement for the last six weeks." And that is a direct reflection on counsel not properly educating their client and the appellate courts are gonna take notice of that. We'll talk about what his chances are gonna be on appeal. But they will not — they read that transcript.

Mandy and I think that the system is done giving him special and Dick special treatment. If they're gonna let it sit and simmer on a back burner for a long time.

He used the word "hurt." I didn't wanna hurt them. I think to Alex, in his weird bizarre mind, I think that he believed saving them from the disgrace of the downfall, of reveal. I don't know.

Satterfield case is first up."

So, he doesn't know how to do any of that other stuff, which is appeal to the judge in terms of showing that he's sorry or confess — he just doesn't know how to do any of that.

All of that was coming through the floorboards and it was — this Black man here now gets to tell the grandson of Buster Murdaugh how it's gonna be. The power dynamic shifted in that moment.

He's incredibly guilty. Like the jury said, we find you incredibly guilty. They just didn't find him guilty. They found him incredibly guilty. And what it did is it took the mystique away from the Murdaughs forever. Look, the judge was mad. He, you know what made him mad? That he had to take down photograph — paint portraits of solicitors. You're, you know, you disgraced your family so much that I was forced to dishonor them and take their portraits off the wall. I now feel that I can stand up. I always would stand up to a Murdaugh. Obviously, I sued them. But there still was a fear in me of is there gonna be retribution from different people. Today, I don't feel that retribution. I feel there's whoever may be mad at us or voice their opposition to us on social media, they are a small, small minority.

The way the Murdaugh walked into court was stench and power for me was the power and privilege. And then, then they get moved back and they're mad that they get moved back because they broke the rules and.
