On June 7, 2021 at approximately 2226 hours I, Sgt. Greene responded to 4147 Moselle Rd in Colleton County in reference to two gunshot victims found by the caller.

Synopsis: On June 7, 2021 at approximately 2226 hours I, Sgt. Greene responded to 4147 Moselle Rd in Colleton County in reference to two gunshot victims found by the caller.

When I arrived on scene I found two individuals, Paul Murdaugh and Margaret Murdaugh, lying on the ground with apparent gunshot wounds to the head. The complainant, Richard Murdaugh, was standing by his vehicle nearby. I advised CCSO dispatch that the scene was secure for CCFR medics to come in to the victims. Investigators were already notified and responding to the scene. Richard Murdaugh advised me that he found his wife and son with gunshot wounds to the head and retrieved his firearm (a 12 gauge shotgun) from the residence nearby in case the suspect(s) returned. I secured the shotgun which was leaning against Richard Murdaugh's vehicle and placed it in my patrol vehicle.

As other units arrived on scene, the crime scene was secured with crime scene tape and only essential personnel were allowed access. Dep. Pruitt started a crime scene log (see Pruitt's supplement).

CID began arriving on scene shortly after my arrival and the scene was turned over to them.

Nothing further to report at this time. End of report.

I Deputy Pruitt arrived on scene at 4147 Moselle Road in Colleton County in after SGT Greene and Deputy McDowell and Colleton County Fire Rescue. When I arrived on scene I began to tape of the crime scene. Once the crime scene was tapped off and after SGT Tindal arrived on scene I began a crime scene log of who entered the crime scene.

On Monday June 7, 2021 I Dep. McDowell responded to 4147 Moselle Rd. in the Islandton area of Colleton County in reference to a shooting incident. Once on scene I helped Sgt. Greene establish a crime scene, located and marked three shell casings with crime scene tape, and took a post on one side of the scene to prevent family members from entering the scene. Once enough units arrived on scene I left and resumed my assigned road patrol duties. Nothing further.

On 6/8/21 I Lt. Polk along with Lt. Crosby located one of the victims vehicle, Paul Murdaugh, (2008 Ford F-250 white over tan bearing license plate IZF-269) in front of 4736 Hwy 63, Hampton Co., unoccupied. The vehicle was facing in the direction toward Walterboro,SC. Vehicle was towed by rotation, Advantage Towing, to the Colleton Co. Sheriffs Impound Yard. Misc. damage to the rear tailgate (dent and partial missing trim), Dent right rear qrtr panel, damage driver side mirror. Tire jack in bed of truck along with misc trash, beer cans, blue bucket. Appeared to be two "boxes" of ammo on rear floor behind front passenger seat. No keys to the vehicle. Tow sheet was completed. Nothing further.

Upon arriving on scene, Sheriff Hill instructed me to ride Moselle Rd and look for homes or businesses that may have exterior home security cameras facing the road. I did Identify(3) homes on Moselle Rd. with cameras.

██████████ Moselle Rd owner Kimberly Campbell. Telephone contact was made with her and she did have her son download pictures from the camera and those pictures were sent to IT Specialist Richard Haley.

██████████ Moselle Rd. When I got out to make contact with this home owner, Det. Sgt. James Washington told me he had already made contact with a family member of this home owner and that they are going to get video downloaded and get it to Sgt. Washington.

██████████ Moselle Rd, I saw has a Ring door bell. I spoke with the home owner, Tom Polk and he told me that the Ring unit is not currently on his phone but his wife Mandy does have it on her phone and he will have her attempt to download when she returns home.

Supplement Narrative By Richard Haley

6-8-21

At 1016 I Deputy R. Haley was contacted by Lt. G. Rioux to meet up with Lt. K. Crosby at the ball fields off of Moselle Rd. in Islandton which is in Colleton County off of Hwy 63 in regards to pulling Video footage from homes that are located on Moselle Rd. Upon meeting with Lt. K. Crosby we ended up going down Hwy 63 in regards to one of the victims vehicles being located off of the road about a mile and half into Hampton County. We left the vehicle with Lt. W. Polk to have it towed back to CCSO HQ. We drove back down Moselle Rd. and went to 3 locations to see about getting video footage.

██████████ Moselle Rd, Dispatch made contact with the owner of the property, Kimberly Campbell. Telephone contact was made with Ms. Campbell and she had her son, Jacob Campbell on the other line and merged our calls together. I stated that we were looking for any and all video footage from 6-7-21 5pm through 10pm. Jacob Campbell was able to download and save the video footage to his Google Drive and shared to my Colleton County Email address. I

downloaded the footage and copied up to the CID Case File 21-2008 folder. Jacob stated that they had the cameras set to only cut on with movement that was in the yard so they were not getting notifications for every vehicle that went down the road. A copy of the videos were burned to a CD and delivered to SLED in Walterboro.

██████████ Moselle Rd. Once we went to make contact with the home owner, Sgt. J. Washington stated that he made contact with the home owner and he was going to have a family member download the video footage requested and get to Sgt. J. Washington.

██████████ Moselle Rd. We made contact with the home owner Tom Polk and he stated that he just got a new phone and did not have the ring software setup on his phone and his wife would need to download the videos from her phone when she got home. Mr. Polk stated that he did not believe this camera was catching all movement in the road but just for when people waked up to his front steps.

Supplement Narrative By Lonnie Nettles

On 6/7/21, at approximately 10:07 PM, I, Lt. L. Nettles, responded to 4147 Moselle Rd. with other units for a report two gunshot wound victims. Upon arrival, deputies had secured the initial crime scene. Two individuals were observed laying on the ground covered by pink sheets. I then assisted with extending the crime scene with a secondary perimeter with additional crime scene tape. I then stood by on the perimeter of the inner crime scene. Agents from SLED arrived and took over the crime scene for processing. I was then released from the scene.

Supplement Narrative By George Rioux

Reference A:

A double homicide occurred at 4147 Moselle Road.

Officer's Observations/Actions:

On the morning of 6-8-2021 I was contacted via telephone by Sheriff Hill and directed to assist the SC Law Enforcement Division in the investigation of this case. It was requested that deputies search the area near the crime scene for video surveillance camera systems on nearby residences. CCSO Sgt. J. Washington and I paired up to ride together. Other CCSO Deputies were also working together on the same assignment. The area that Sgt. Washington and I worked was from Moselle Road towards the Hampton county line all the way into Hampton County at Highway 363. We also checked Dopson Road. The following were a list of our results:

██████████ Snider Highway - Cameras present, however they do not work.

██████████ Dopson Road - Cameras present, however they not worked in approximately four months

██████████ Sniders Highway - Cameras present and working. Matt with Palmetto Rural Telephone is the manager and operator of the cameras. Sgt. Washington called his phone number at ██████████ and left him a message to call him back.

Supplement Narrative By David Long

On 6/07/21 at about 22:30 I was contacted by Captain Chapman and informed of a shooting involving two victims in the Islandton area. I responded to the address he had provided, upon hearing my radio transmission that I was on the way Capt requested that I divert to Headquarters and retrieve at large tent to cover some of the evidence exposed to the elements. I did as instructed and arrived at the scene and deployed the tent over the female victim in an attempt to preserve as much evidence as possible. While assisting on scene, the Medical Examiner had contaminated his gloves and asked if i would use his camera an take the necessary photos he required and I did so at his direction. I remained on scene until Sled Crime Scene had completed their effort at the incident location.

Supplement Narrative By Richard Haley

6-9-21 I Deputy Haley was requested by Lt. K. Crosby to meet him out at S&G Grocery in regards to pulling video. Upon arrival I met with Lt. K. Crosby and the store owner Ulises Gonzalez. The video exported was for the date of 6-7-21 and the time frame was 1700 through 2200. The video footage was of the gas pumps looking towards the intersection of Hwy 64 and Cross Swamp rd. The video footage was copied up to the CID OCA 21-2008 folder and a copy was burned to DVD and the copy was delivered to SLED Agent C Ghent.

I communicated with Matt Williams and Lavern Polk of Rice Patch church and was giving permission to connect to their WIFI and pull video footage from the church. The video footage that was pulled was from the camera pointing in the front of the church which shows Hwy 63. The date and time of the footage that was pulled was of 6-7-21 1700 through 2200. The video footage was copied to the CID OCA 21-2008 folder and a copy was burned to DVD and was delivered to SLED Agent C Ghent.

Lt. K. Crosby emailed me a link from [REDACTED] Moselle rd. of the Ring Doorbell. The video was downloaded and copied to the CID OCA 21-2008 folder and a copy was burned to CD and was delivered to SLED Agent C Ghent.
