I don't know if we will ever fully understand Alex's ongoing schemes to hide the truth. But as a matter of public interests, the legal system seems to have fallen on the side of transparency and after officials released the jailhouse phone call recordings we now have a much clearer understanding of the suspended attorneys and volunteers solicitors relationships, plots and life behind bars. My name is Mandy Matney. I have been investigating the Mudaugh family for more than three years now. This is the Mudaugh Murders Podcast with David Moses and Liz Farrell. So to start out, I have some really good news. Last week Richland County officials told FITS News and the Mudaugh Murders Podcast, they decided to release Alex Mudaugh's jailhouse phone calls and that is a big deal. We would like to applaud Chris Ziegler, the Richland County assistant attorney for doing the right thing. And we also want to thank our MMP supporters who are following us on social media and wrote to public officials and applied the right amount of pressure. In this case, this decision shows the world that sunlight and transparency can ultimately prevail. And now at least some SC officials want to be on the right side of history. So after waiting all weekend and convincing ourselves that we were fooled, and the tapes were never coming, the US Postal Service brought us a whole lot of sunshine in the form of five sparkling rewritable CDs. Remember

those? Yes, the Richland County government uses CD ROMs delivered by mail technology that was available when I was in elementary school to fulfill their FOIA requests. But I will complain about that another day. Both the FITS News and MMP teams have been working tirelessly, listening to hours and hours of phone calls between Alex and his family members. Just as we anticipated, the phone calls were full of newsworthy information, and we will play some of those clips here in a minute. We have maintained from the beginning that these tapes are important to holding Alex and the legal system accountable. And we believe it now more than ever because of the tricks Dick and Jim tried in keeping the tapes from being made public. Other podcasters and critics on social media seem to think we were never getting the tapes, and that we were out of line even asking for them in the first place. They even erroneously claimed that the lawsuit had the chance of making case law and federal court and mainstream media remain silent as Dick and Jim use the federal court system to prevent us from hearing Alex's calls. It's going to be really interesting to see whether those podcasters and other media outlets also requested the tapes. While we believe in the public's right to access public information. This one hits a little differently for us because well FITS News and the Muraugh Murderers Podcast fought to get those tapes. The vast majority of South Carolina journalists covering this case did nothing, not even a supportive tweet or even a behind the scenes, we're with you on this. And the South Carolina Press Association who call themselves defenders of the Freedom of Information Act did nothing. And that's shameful in my opinion and honestly shows how deep the corruption goes in the state. And for me, it confirmed what I had been suspecting, the SC Press Association is probably a part of the good ole boy system too. I say all of

this because I'm sure other podcasters and YouTubers and documentarians and other true crime hacks are going to play these tapes without acknowledging in the very least bit the work the FITS News did to keep this case in the sunlight. And now the rest of those hacks will likely profit off of the hard work of others, which is unfortunately the sad state of media today. So before we get into the calls. I would like to kindly suggest that those listening to this podcast subscribe to fitsnews.com and show your support for the media outlet in South Carolina fighting for the truth and transparency. So the calls. To give you an idea of what we're working with here, we had 11 phone calls for the last episode that we did on the jailhouse tapes back in February. Those calls were chosen because they were either mentioned in the prosecution's memo for Alex bond reconsideration hearing, or they occurred on a date that held significance. After we received those calls several months ago, we filed an additional Freedom of Information Act for the rest of the calls between October and February. In total, we listened to more than 100 jailhouse phone calls in the last few days. We have also filed for years for recent phone calls but we anticipate it'll be a while before we receive those. As expected the phone calls were dense and it was really hard to get through one without stopping and saying What did he just say? Not only were they difficult to hear they were packed with information and I'll be honest here the calls were very emotional at times for the first time in all of my reporting, I started to understand why Alex was loved and believed by so many around him human beings are complicated and with Alex it's hard to understand a man accused of such horrific crimes could also be this guy who appears to show genuine concern and love for his family members.

Name is plants hair like Israel, that I'll get his number.

Let me...if you want if you can hang on one second. I can go down to my computer and see if I can just type it in.

He's still gambling.

Mandy Matney 09:09

He's still enjoying his jail snacks.

Alex Murdaugh 09:12

No, the food's so bad. But Jim put some money on his canteen so hopefully ordered it today they say hopefully it'll come Thursday. I mean when Monday and what is little food like pop tarts and some funky stuff.

Mandy Matney 09:35

he still loves explaining canteens to his family members and those beef sticks.

Alex Murdaugh 09:43

Canteen as you go to this kiosk, you know the kiosk is right. Yeah, it's like the little computer machine and I know what a kiosk is. So you go to the kiosk and you place your order. And you can order any array of things like Um hygiene products this that the other didn't get, you know all these foods, tater chips, a bunch of varieties of the pay to Kipps. Some are sauces and beefsteaks, crackers, and you can order but you can only order \$60 worth. And you order like you have to order by Wednesday. And the canteen delivers on Monday. So like a Monday,

they bring you a big bag or whatever you ordered. You say you got \$60 per transaction or like \$60 a week or a week, six hours a week.

Mandy Matney 10:37

He's still working out and talking about it a lot like every phone call practically.

Liz Murdaugh 10:44

When exercise do you do it with a buddy or like that in your prod or you just do it by yourself.

Alex Murdaugh 10:52

You always kill me with your questions. Hasn't been my buddy. I use I usually try to do it in my room. Two hours, it takes me an hour to do those Up Downs of burpees as you call them, and mountain climbers it takes me about an hour to do those 12 sets. And then I run in place you know in the struggle in my arms for about 20 minutes.

Mandy Matney 11:21

He's still getting into some rather alarming mishaps.

Alex Murdaugh 11:26

What was the Alabama final? Something like that. You won't believe what I did. After I finished doing my exercises, I went to go get in the shower before food comes, there's no officer here. Damn if I didn't lock myself out. I'm standing there with no clothes. I mean I got stuff over my bottom. What y'all doin'?

Mandy Matney 11:57

Okay, I have to repeat that. Alex Murdaugh locked himself out of jail with no clothes on. And he wanted to chit chat with Buster about the Alabama score before telling him about his predicament. And we will be right back okay, so all jokes aside, Alex Murdaugh is still up to the same head scratching schemes. And we will get back to this one in another episode.

Alex Murdaugh 12:31

Do a three way and get Jim on the phone. I want to see if I'm crazy, or that's what he told us.

Mandy Matney 12:40

He's also still manipulating his family.

Alex Murdaugh 12:44

Or call John I got two minutes and I'm not gonna better make another call. I need \$28 on the canteen because it's Thanksgiving, the deadline is 10 o'clock in the morning. So I need to order it tonight because I'm not gonna get out in the morning and tell them I made my status change. But they haven't implemented it yet. So I haven't had any kind of tell John that I'll be calling him tomorrow. I'll be calling you tomorrow. I'm sending you a letter. Where do you want me to send it to John's house? John's house. Alright, and I usually text Randy and Lynn on the weekend where you can tell them I haven't been able to use the phone and I'll give them a call when I can. Yeah. Alright, so text Randy and Lynn, jump off and \$28 is the most important thing that needs to be

done right now. Okay, and call you in the morning. All right, so what am I texted Randy, just tell them I normally call them on the weekends. But I haven't been able to call him and tell him I haven't been able to call. I can only talk for a second I'll give them a call when I can. And jump on and put \$28 on my cat jump on the lid and they don't know how to do it. Oh my canteen account. And I love you to Brooklyn. Hey, I love her and I'll call you tomorrow. Starting tomorrow should have a lot more time. No metoda Thursday I was Yep. But it hadn't come into fruition yet, but it should tomorrow. I love you.

Mandy Matney 14:19

Man. Even aside from the double homicide and the mysterious death surrounding his family, Alex is accused of some very ruthless behavior. And you think about all the victims who have been pulled into Alex's mess who have never been the same. You think of people like the beach family and everything Alex has put them through in refusing to admit fault in his son's boat crash and not settling in the lawsuit. Then you hear one of the very first phone calls Alex placed while in jail. And you remember why this guy is where he is.

Liz Farrell 14:59

We don't have the very first phone call Alex made from jail because Richland County held back a number of calls citing various FOIA exemptions, but we do have the second call and it was rather unsettling. You know how you know, you know something, but then you find out you didn't really know because you didn't hear it for yourself. We knew Alex was accused of going on a liquidation spree and turning his assets into cash to allegedly keep his money away from the

beach family and other victims and other potential creditors. We also know that he had been accused of prioritizing creditors like friends and family and Palmetto State Bank, but hearing someone accuse Alex of doing this, and then hearing Alex do it are two different things. Let's set the scene for you. Sometime after Alex was photographed at a Buccee's somewhere near Orlando he was arrested October 14th 2021. And then extradited to South Carolina on October 19th. He was denied bond much to his surprise and he was awaiting the results of a psychiatric evaluation for the judge to reconsider his decision. Alex's second call from jail was made two days after this. He's still in quarantine for COVID. And according to a form we received in March from a FOIA we sent to the jail Alex was in protective custody because the jail was concerned for his safety but also Alex had signed an affidavit asking for them to drop protective custody. And he did this right away even before the hearing now John Marvin, Alex's younger brother is with his family in Sedona, Arizona. John Marvin is married to a woman named Liz and on this trip they've brought three kids and a buster. You guys remember the Las Vegas photo of Buster and John Marvin gambling that was taken just before this. Okay, so again, this is a second call from jail. To us, it seems like you know, kind of a pretty big deal that he's a Murdaugh and now he's calling from jail as if he's at a hotel and nothing's out of the ordinary, but he's just like, hey, what's happening? Also, he wastes absolutely no time in getting to the point. Oh, and the point is to quickly liquidate his assets and keep them away from the victims and potential creditors who aren't his friends family or Palmetto State Bank.

Alex Murdaugh 17:12

Hey, man, how you doing? I hope I'm not calling you too early out there. No, no, we've been up for a while. We just got breakfast. What time is it out there? It's almost no. Okay. Cancel. Yeah. How's Boston? Good. Hey. Yep. In court the other day, they made a big deal about things they're gonna be moving to try to prevent us from selling stuff. Right. We need to do get as much as we can complete it. And on that note, Did Mark Bala respond to you? If you did not follow up with that morning. I just know that they're getting ready to stop and I mean, I don't know if it's gonna be a day or a week for you know, two weeks maybe would theoretically have to serve me or buster. But Russia extend service? Well, let me ask you a question. Alex. So the I'll follow up with with Randy and mark on that. But the the belt truck and excavator. Yeah. What are your you have an issue if I bomb everybody's water? No issue at all.

Liz Farrell 18:40

This seems super generous, right? And maybe it even makes sense because John Marvin owns a heavy equipment rental and sale center. But by buying the equipment, John Marvin is expediting the situation while keeping the assets in the family time is of the essence here because Mark Tinsley and the court are closing in now remember, Alex and John Marvin are very aware they are being recorded, or rather, they're intermittently aware. And I say that because there's no other explanation for how they go in and out of saying something that would be dumb to say on the record, while also saying things that sound like they're playing to the audience. I also want to know if Alex and Randolph took out a \$600,000 line of credit from Palmetto State Bank

in September, a month before this phone call the bank put a claim in against Randolph estate. These guys were selling Alex assets to pay back that debt. So there would be no claim against the estate, which these guys will be inheriting anyway.

Alex Murdaugh 19:42

That's not me. That'll be the easiest way to do a sale. If you need them. Don't do it just to help me. So you know, I haven't seen anybody by since I left that. When I left. I didn't have any buyers on either side. For those who, like I say, don't do that. I mean, if you should, I'll give them to you. Nope, not gonna do that, but okay, well, I know what to do and I'll be in need of your mama's boy, I don't need them. I just have a useful promise you, given to you. But I'm not gonna do it. Either way, so I'm gonna follow up and see if I've got any, any real leads on them. And you might speak to Jim, if you get a chance, just to find out what kind of timeframe he thinks before they get any kind of order preventing us from doing anything. Okay. And I mean, well, I'm just, I'm just doing everything by the book and squirrel it away is no one to pay bank stuff. Well, it goes to the unsecured notes, so, so everything else has something securing it, so it makes sense. Unsecured items would go to an unsecured note.

Liz Farrell 20:58

So basically what these guys were doing according to this call, this is exactly why Mark Tinsley filed a motion to freeze his assets, and why he wanted to have a receivership appointed. What's annoying is this. Think about all the drama that has surrounded this receivership about how Alex's attorneys John Taylor and then Dick and Jim argued that it would

set a dangerous precedent and how they tried to get it dismissed and how John Marvin did two interviews allegedly trying to set the record straight on the whole thing. He actually lamented to one newspaper that he was nothing but transparent in this apparent scheme to pay back the bank to keep creditors away from the families trust clearly marked Tinsley's idea for receivership was a smart one. It definitely rattled them also sending shockwaves through the Mordaugh clan, Mr. Eric Bland. We'll be right back.

Mandy Matney 21:53

If you remember by October of last year, Eric Bland had emerged as a central player of the Mordaugh's opposing team. Nearly every day in October, Eric Bland was making headlines in the press are his direct and fiery quotes about Alex Mordaugh, like there's no bottom to him, and he is a liar and a cheat. In fact, Eric played an important role of applying pressure to SLED to arrest Alex Mordaugh for the glorious Satterfield case. To everyone's surprise, that arrest is what landed Alex behind bars for the foreseeable future. In a call on October 23. Buster expressed concern over the upcoming receivership hearing something Eric was very vocal about as he was advocating for all of the victims in this case, not just his clients.

Buster Mordaugh 22:48

Yeah, man doing good. Just you know, the new developments with the motions and everything trying to get us to quit selling stuff. I don't know really what that's gonna have what has in store.

Alex Murdaugh

I told y'all this was coming. Yeah, man. This is Eric. This, Eric. He said that was common. No, I just saw it on Twitter, now called John the other day to tell him he needed to do it as quickly as possible because they will be doing it any day.

Buster Murdaugh 23:17

This Eric was Eric Bland. Yeah, seems like a real charm. You know, this is five minutes in the sun, you know?

Alex Murdaugh 23:28

Yeah. I can't believe John until you get I said that the other day. Whatever day I called. When I went to court that afternoon when I called on Wednesday. I mean, I don't know what do you think be done? So then we need to get in touch with Mark ball. Get that funds. Get it on at 30. I didn't know how quickly it was gonna be done. I said it could be any day now. It could be three days. It could be a week, but it was coming. Well, it's done now. So no reason. Threatened ever. No, he's filed a motion. He doesn't have an order yet. No, no,

Buster Murdaugh 24:05

I understand that it's not ruled upon. And I would think they gotta serve me to do it.

Alex Murdaugh 24:12

Well, but you'd have to serve one of us if they're going to stop if they're going to stop me from doing something. But they can only serve you if you accept service. They can't serve you. They could serve you

individually to keep you from doing anything as power of attorney. But that'll keep John Marvin from selling. You know? I mean shit that ain't got titles especially.

Mandy Matney 24:38

The plan to sell off assets and move money quickly appears to have involved Alex's former law partner Mark Ball in some way though, according to the calls Ball had not been returning the family's phone calls during the conversation on October 23. Mark Ball's name should sound familiar.

Liz Farrell 24:59

He was allegedly involved in the old jellyfish gambit. He was also Alex colleague a PMPED. His name also came up in the first round of calls that we played in the last episode on the phone calls it sounded like Mark Ball was cutting a very important check for Alex Murdaugh just days after a receivership was in place whatever ball was doing Alex wanted it done fast.

Alex Murdaugh 25:22

I just told John, we need to, they're going to move to try to stop us from selling stuff. We need to get the marketing them are going to do that they need to do it. We need to get that on that note ASAP, and get money on it ASAP. You know what, there's gonna be a day or a week or two weeks that they're gonna move to stop us from selling access.

Liz Farrell 25:45

Anyway, during this call, Alex says something worth noting about John Marvin to his son.

Alex Murdaugh & Buster Murdaugh 25:53

Yeah, well, you know, John was too scared to do anything that's teetering. I said John Marvin was too afraid to do anything just teetering. You know what I mean? Did he follow up with Mark Ross, though? I mean, yeah, we we've reached out the mark, but he won't get back in touch with us. Been that way for two weeks. So we've been reaching out to Mark but he won't get back in touch with us. He's been that way for two weeks. He doesn't respond, respond to our emails, our or our calls. What really will do anything with it? Not me. I think Randy's trying to help. I just don't think you'll call them in either.

Mandy Matney 26:31

Eric Bland also came up during one of Alex's many phone calls with his sister in law Liz, who was John Marvin's wife. Now Alex talks to Liz Mudaugh a lot. He has a close relationship with his sister in law. We mentioned Liz Mudaugh in the last jailhouse phone call episode when Alex was trying to get her to put money on his buddy's canteen, which is against the rules by the way. So by November Alex Mudaugh had been publicly accused of a lot of horrible things. He was accused of stealing millions of dollars from clients, including his dead housekeeper's family in an injured state trooper. He was also charged in those crimes, and there was a paper trail of evidence supporting those charges. I say this because at this point, Liz Mudaugh should have known that her brother in LA has some serious issues and has done

some inexcusable things yet on the phone, especially during this conversation Thanksgiving week, she appears to support him 100% And she doesn't even seem to mind when Alex asked her to do things for him.

Alex Murdaugh 27:43

I gotta get emails, we even need a favor. Where you send me a letter with everybody's email address. You know, I really yours and busters and John Marlin can send it to me first rather than having to do another one. Just send me everybody's email. And there's a machine that we can have video calls. Without me come here to do a video on how to work the machine and how to pay for it and all that. Okay,

Liz Murdaugh 28:20

So what emails do you want me to send? I got a pencil handy.

Mandy Matney 28:24

Now in November attorneys Dick Harpootlian and Jim Griffin were busy fighting for Alex Muddaugh both in the civil and criminal court, but Eric Bland was a big problem for them at nearly every turn. Remember, Dick and Jim filed a motion to dismiss the Satterfield lawsuit because basically other people paid for his thievery in response, Bland called Alex despicable and a coward all over the media. Dick and Jim were also filing paperwork and attempting to get Alex out of jail which Bland called a desperate act by a desperate man. It was very clear that Bland was a huge problem for teen Muddaugh in November and Dick and Jim made a shocking move then to not only silence Eric Bland, but they filed a complaint with the bar to go after his law license, which is lower

than low. Anyways, this November 23 Call from Liz Muddaugh shows just how loyal the family is to Alex.

Liz Murdaugh 29:24

I'm excited about that gag order.

Alex Murdaugh 29:26

So have Jim and Dick told you about that?

Liz Murdaugh 29:30

No, but it's already online. It's already online.

Alex Murdaugh 29:35

Oh, it is?

Liz Murdaugh 29:37

Yeah.

Alex Murdaugh 29:44

I mean, you know, he, they tell me he's running his mouth.

Liz Murdaugh 29:50

Yeah, just ruthlessly. ruthlessly. Just kind of like then I'm like you just say Make bit not run on every every other word.

Mandy Matney 30:03

Alex and Liz Muddaugh talk a lot. We'll get into more about their relationship in another episode, but he tends to open up, he tends to

open up to her about stuff that he just really doesn't talk about in detail with his other family members. Like for instance, his little roadside shooting incident.

Liz Murdaugh 30:23

Okay this is something else I've been wanting to know. He says that you went blind. So again, when you got shot? Blind, I don't know for how long?

Alex Murdaugh 30:36

Yeah, I mean, I couldn't see for I don't know, I guess a minute, minute and a half, maybe two minutes, a minute.

Liz Murdaugh 30:45

I mean, do you feel like you were near death and that you were seeing the light? No.

Liz Farrell 30:50

Sometimes it's hard to remember that there are a handful of people out there who actually believe that Alex got injured in a failed suicide for hire plot. We can't say Liz Murdaugh isn't devoted to her cause but she has gone a little too far imagining any scenario in which Alex Murdaugh hits his head, an angel start playing their welcoming harps. You and I both know heaven went into DEF CON one shutdown mode. The second he got a little woozy from the quote, entrance and exit ones.

Now remember, Alex's attorneys claimed in the media that his injuries were much more serious than originally reported. And they said he was lucky to be alive. But Alex describes it differently.

Alex Murdaugh 31:37

No, it wasn't that bad. It just I guess it was the impact. I mean, I wouldn't see in light I would see in dark. I mean, the first thing. I mean, the first thing I thought was one minute remaining. And then I'm like, I know I'm not dead. Because, you know, I mean, I just remember touching my hand I remember. I mean, I remember thinking the back of my head blown off, and I'm gonna be blind. And then, you know, it slowly started coming back, I could stand up because it knocked me down. And then I could stand up, I knew I was standing up. And then I pick up kind of with the one knee. And, you know, I couldn't see you know, it didn't take it didn't take long at all. Before it started improving.

Mandy Matney 32:31

He claims he initially thought his injury was a lot worse than it actually was.

Alex Murdaugh 32:36

Couldn't see now for a second I thought to myself, in my head, it didn't take me long to realize I wasn't dead, then the next thing that occurred is, oh my god, I'm really gonna be messed up. I'm gonna be blind. And then it started quickly, coming back, but I mean, I mean, I could reach back and feel my head and I knew my head was missing. You know, I
