THE CP HAD NO TEXTS OR PROOF OF HARASSMENT AND WAS ADVISED BY R/O TO BLOCK ANY FURTHER SOCIAL MEDIA FROM HIS WIFE AND HE WAS ALSO ADVISED TO NOT LOOK AT HER PAGE SINCE IT UPSET HIM. THE CP MENTIONED DEFERMENT OF CHARACTER BUT WAS TOLD THAT IS NOT A CRIMINAL MATTER AND THAT THERE WAS NO EVIDENCE FROM WHAT DET. PAITSEL AND R/O SAW OF ██████████ MENTIONING HIS NAME ON ANY OF THE SOCIAL MEDIA THAT WAS POSTED. THE CP STATED THAT HE WAS A PASTOR AND HE WAS WORRIED ABOUT HIS REPUTATION.
