NARRATIVE

ON FEBRUARY 21, 2024, I MET WITH THE COMPLAINANT (CP) AT 300 COASTAL GRAND CIR, IN THE CITY LIMITS OF MYRTLE BEACH, IN REFERENCE TO THE REPORT OF A STOLEN VEHICLE.

THE CP STATED THAT SHE HAS BEEN SEPARATED FROM HER HUSBAND, THE INVOLVED OTHER (I/O), SINCE JANUARY OF 2023. THE CP STATED THAT SHE WAS INVOLUNTARILY HOSPITALIZED ON 2/8/2024 AND LEFT HER SILVER 2019 HONDA ACCORD PARKED IN THE PARKING LOT OF THE WALMART NEIGHBORHOOD MARKET LOCATED AT 3650 WALTON DRIVE. WHEN THE CP WAS DISCHARGED FROM THE HOSPITAL, HOSPITAL STAFF INFORMED HER THAT HER HUSBAND PICKED UP HER PURSE AND CAR KEYS WHILE SHE WAS HOSPITALIZED.

THE CP STATED THAT, WHEN SHE WAS RELEASED FROM THE HOSPITAL ON 2/10/2024, SHE RETURNED TO THE WALMART NEIGHBORHOOD MARKET ON WALTON DR AND DISCOVERED HER VEHICLE WAS GONE. THE CP BELIEVED THAT HER HUSBAND FRAUDULENTLY INITIATED HER INVOLUNTARY HOSPITALIZATION AND "STOLE" HER CAR WHILE SHE WAS IN THE HOSPITAL.

THE CP STATED THAT SHE HAS KNOWN HER HUSBAND SINCE SHE WAS 10 YEARS OLD AND THAT HE "GROOMED" HER WHILE SHE WORKED FOR HIM AT SOLID ROCK CHURCH UNTIL THEY WERE MARRIED SIX YEARS AGO.

I CONTACTED THE HUSBAND (I/O) WHO STATED THAT HE AND HIS WIFE WERE NOT LEGALLY SEPARATED AND THAT SHE SUFFERS FROM MENTAL HEALTH DISORDERS. THE I/O STATED THAT THE CP EXPERIENCES "EPISODES" ON AN ANNUAL BASIS, NEAR CHRISTMAS, WHEN SHE BECOMES RECKLESS AND SPENDS LARGE AMOUNTS OF MONEY WHEN SHE STOPS TAKING HER PRESCRIBED MEDICATION. THE I/O STATED THAT HE WAS IN POSSESSION OF THE SILVER HONDA ACCORD IN ORDER TO PREVENT HIS WIFE FROM SELLING IT DURING THIS EPISODE. THE I/O POINTED OUT THE FACT THAT THE VEHICLE WAS MARITAL PROPERTY AND THAT HE WAS UNWILLING TO GIVE IT BACK TO HIS WIFE FOR A MONTH, WHICH HE STATED WAS USUALLY THE TIMEFRAME OF THESE RECKLESS EPISODES.

DUE TO BOTH PARTIES STATING THEY WERE LEGALLY MARRIED, I MADE THE DETERMINATION THAT THE HONDA ACCORD WAS CONSIDERED MARTIAL PROPERTY, THEREFORE, I COULD NOT ESTABLISH A CRIMINAL OFFENSE.

I HAVE NOTHING FURTHER AT THIS TIME.
