Robeson County Communications Center E-911

- 2:54 p.m., April 27, 2024: a 911 call made from 843-655-5242
- Mica Miller asked if her phone could be located and then threatened suicide. Mica hung up the phone before further information could be obtained by the telecommunicator.
- The telecommunicator attempted to call Mica back multiple times and was unable to make contact with her.
- The telecommunicator utilized RapidSOS to locate Mica.
- 3:03 p.m., Robeson County Sheriff's Office Deputies were dispatched to the Lumber River State Park at 2819 Princess Ann Rd. in Orrum, NC, in reference to a wellbeing check and to attempt to locate Mica.



Response

- 3:05 p.m., contact made with the Lumber River State Park Superintendent.
- 3:20 p.m., Deputies request phone ping
- 3:31 p.m., Deputies arrive at Lumber River State Park and begin search with State Park Rangers.
- 3:33 p.m., Robeson County Sheriff's Office, Aviation Division, Air 3 sUAV (Drone) dispatched to Lumber River State Park.
- 3:42 p.m., Telecommunicator contacted Verizon to request updated location ping.
- 3:50 p.m., Detectives with Air 3 sUAV arrived at Lumber River State park.

Robeson County Sheriff's Office Response

- 3:42 p.m., Detectives located a black Honda Civic in the parking lot of the Lumber River State Park with South Carolina registration 301AKH, Robeson County Communications confirmed the vehicle to be registered to Mica Miller. Detectives looked inside the car and observed a black Sig Sauer gun case in the passenger seat and a box of ammunition in the center console of the vehicle. This information was relayed to Deputies and Park Rangers actively searching the park.
- 3:45 p.m., Detectives deployed Air 3 sUAV to conduct an aerial search of the area.

Robeson County Sheriff's Office Response

- While conducting an aerial search, Detectives were approached by an individual who stated he had found a bag while fishing with an ID inside belonging to Mica Miller. Detectives took possession of the bag.
- The individual stated he heard crying while he was fishing then a gunshot. The individual stated he went further into the slough where he located the bag about two foot from the water edge.

Robeson County Sheriff's Office Response •4:23 p.m., An individual contacted Robeson County

- 4:23 p.m., An individual contacted Robeson County Communications E-911 and advised he had located a body in the water. The individual had been fishing in his Kayak when he located the body in the river.
- Searching Deputies and State Park Rangers went to the individual's location and confirmed the information given. The area was then secured for investigation.

- 5:30 p.m., Chief of Detectives for the Robeson County Sheriff's Office arrived at incident location.
- 5:54 p.m., Detectives along with Robeson County Sheriff's Office CSI Technician arrived at the incident location.
- Medical Examiner was contacted and requested to come to incident location.
- CSI technician photographed the area of investigation to include the vehicle belonging to Mica Miller. Items of evidence were collected from the incident location and from the vehicle of Mica Miller.





- License plate readers identified John Paul Miller's truck traveling towards Charleston, SC.
- Eyewitness statements obtained by Detectives confirmed John Paul Miller stayed overnight in the Charleston, SC area.
- License plate reader identified John Paul Miller returning to Myrtle Beach, SC. Miller's truck was last captured by license plate reader on Hwy 17 Bypass in Horry County in SC at 2:22 p.m., on Saturday, April 27, 2024.
- While traveling to and from Charleston, SC, John Paul Miller was accompanied by other individuals.
