NARRATIVE

ON 03/13/24, A REPORT WAS RECEIVED OVER THE TELEPHONE REGARDING AN ALLEGED FALSE PRETENSE SWINDLE THAT TOOK PLACE AT SOLID ROCK MINISTRIES, 803 HOWARD AVE, WHICH IS IN THE CITY LIMITS OF MYRTLE BEACH.

THE COMPLAINANT (CP) RELATES THAT ONE OF THE EMPLOYEES OF THE CHURCH (OFFENDER) WAS SENT TO COLLECT DONATIONS FOR THE CHURCH'S 501C3 CALLED "DARE TO CARE MISSION." THESE FUNDS WERE BEING COLLECTED SPECIFICALLY FOR A MISSION OCCURRING IN JEBROCK, KENYA.

THE CP STATES THAT, ON 02/14/24, IT WAS DISCOVERED THAT THE EMPLOYEE HAD TRANSFERRED DONATION FUNDS FROM THE CHURCH'S ZELLE AND CASH APP ACCOUNTS TO THE EMPLOYEE'S PERSONAL SOUTH STATE BANK ACCOUNT.

THE EMPLOYEE ALSO COLLECTED CASH DONATIONS WHICH WERE ALLEGEDLY DEPOSITED DIRECTLY INTO THE EMPLOYEE'S BANK ACCOUNT. IN TOTAL, THE CP REPORTS THAT \$1,199 WAS DEPOSITED BY THE EMPLOYEE INTO HER PERSONAL ACCOUNT.

AN INVESTIGATION WILL FOLLOW.
