USE OF OFFICIAL POSITION FOR FINANCIAL GAIN

That Rebecca H. Hill, former Colleton County Clerk of Court, knowingly used her official position to direct a bonus to herself in the amount of \$2,000.00 in September of 2021 from IV-D child support funds, in violation of Section 8-13-700(A).

COUNT TWO
USE OF OFFICIAL POSITION FOR FINANCIAL GAIN
SECTION 8-13-700(A), S. C. CODE ANNOTATED, 1976, AS AMENDED

That Rebecca H. Hill, former Colleton County Clerk of Court, knowingly used her official

position to direct a bonus to herself in the amount of \$380.10 in March of 2022 from IV-D child support funds, in violation of Section 8-13-700(A).
