be called Dr. Miller.

- 21. Wayne would find things to do to keep him away from our home. He would travel and speak, teach at the Bible College and start a Christian academy, daycare, and kindergarten. I didn't mind this; I was very proud of him, but I grew tired of always taking a back seat to everything and everyone. He would continue to preach "fire and brimstone" at church and fuss at me about everything. Either I wasn't doing enough for the church or I wasn't measuring up to his expectations. All our children and I wanted was his love, but he never had time for me or the children. I had no life outside of the church. Our whole life was consumed with the church. He began "giving out" so many doctorate degrees that when I did start back at Horry Georgetown Technical College, one of my sociology professors commented on a church "near our campus" who gives out Ph.D. degrees like water. I was so embarrassed.
- 22. When our son, John-Paul was a teenage, many times Wayne would get into physical fights with John-Paul, and we would have to call the police to our home. Wayne would get angry and lose his temper. Wayne has a very volatile temper. Last year Wayne upset all of us when he got mad at Patrick who was fifteen (15) at the time. Wayne would slap Patrick with a belt and leave scars and bruises on him. Lacy, our daughter, who was eight (8) at the time, would scream and cry terribly. We would beg Wayne to stop, but he would not. He just kept hitting and slapping Patrick and once even had his hands around Patrick's neck choking him. I know he felt bad the next day, but he was horrible at the time. Patrick is a sweet child with a learning disability. Wayne even allowed a teacher in our academy to put Patrick beside her desk and face the other children while she ridiculed and called him "slow". I begged Wayne to stop this, but he would not until I called a psychologist at Socastee High School, Ken Lukenshuk.
- 23. I have always taken care of my children. Since their birth, I have fed them, diapered

them, read to them, prayed with them, taken them to their doctor's appointments, and dentist's appointments. I even drove them to school instead of letting them ride the bus because I wanted to make sure they felt loved and to know that I was there for them anytime. Eventually, Patrick turned 17 and got his drivers license. Then he would drive Lacy to school, but I still would go and pick Lacy up when school was dismissed. Many times I would take lunch to my children after they started attending our Christian Academy because the kitchen facilities were not clean.

- 24. For many years of our marriage, I was so lonely. When my youngest child started school full time, I asked Wayne if I could go back to school. I wanted to better myself, and he offered to give me a job teaching in the academy or kindergarten, but I personally felt like I wanted to be knowledgeable enough in that area and not just pretend I had a degree. I discovered I also had a learning disability. I just learned slower, but studied harder. I wanted to learn new job skills in order to find a decent job. Wayne and his mother thought I could work at Bojangles.
- 25. It still seemed my husband had time for everyone but me, especially his men friends. I felt so starved for affection and love. He would find places to go with his friends, while I was left alone with my children. He made no effort to spend time with me or to love me. I realized my husband had a problem and was not the normal husband.
- 26. Donna, a woman who Wayne had hired, her boyfriend Rick, and I would occasionally eat lunch together. Donna and Rick had broken up several weeks earlier, when Rick phoned me and asked if I would give him a ride somewhere. I said no it didn't look right because I was married. Rick called several times asking for a ride. Each time I would call Donna and ask her to please call him. One time he pestered me so much I broke down and gave him a ride somewhere and then took him back home. He wanted me to come in to see something, and I thought nothing of it. When we got inside, he kissed me, and tried to be intimate. This was certainly nothing I had planned, and it just happened. My relationship with Rick lasted a very short time.

My husband started being suspicious and without my knowledge, connected a tape recorder to our phone and placed the recorder under his bed. I never even suspected a thing. I had no idea he was recording all of my phone conversations until an Horry Telephone employee came to service my phone and found the recorder after the relationship with Rick had ended. Attached is a copy of the letter received from Horry Telephone regarding the recorder.

- 27. I started having back and shoulder pain and went to the doctor. I was told that I could benefit from having a breast reduction. After breast feeding three children for healthy reasons, my body had just taken its toll. My insurance company thought I also needed the surgery. It was not a cosmetic surgery, but a necessary one. I had the surgery in February 2001.
- 28. My relationship with Wayne further deteriorated and Wayne moved out of our home on February 25, 2001 and left me and the children. He moved into a new condominium near our church. He cashed in his life insurance policy which had a cash value of approximately \$15,000.00. He stopped paying the electric and water bills for our home where the children and I live. For the first few weeks after he left, he did buy groceries for the children and me, but he has stopped that. The electric company has threatened to disconnect my electric service due to the past due status of the account. I was required to pay \$179.00, the minimum payment to keep the service from being disconnected. I had to sell my dining room table and chairs to get funds with which to buy food for the children and me. Wayne has had our telephone service at the marital home disconnected, and I was required to pay \$75.00 to have the service reconnected. Had he told me in advance, I could have made arrangements for service to continue in my name without a fee. Wayne has also stopped the garbage pick up service and has stopped paying the water bill. He has failed to timely pay the mortgage payment on our home, and the lender has threatened to foreclose our home.

- 29. Wayne tells me he has no money. However, Wayne has recently purchased an expensive dog for our daughter, entertains as he chooses, takes friends out to dinner, purchased new furniture including a flat screen television, installed a security system in his condominium, and purchased new clothes for himself. He never has money for our food, water, or mortgage.
- 30. I have tried to be fair with him concerning the children. Our daughter stays with Wayne at least two nights each week. Our son, Patrick, does not want to go to his father's home, and since Patrick is almost eighteen, I do not believe he should be required to visit his father. After Wayne moved from the marital residence, he returned while I was not home and took Patrick's bedroom furniture without my knowledge. Patrick has been sleeping on the couch. The upstairs air conditioner unit at our marital residence is broken. I have asked Wayne's help in getting the unit repaired, but he has refused to have it repaired.
- 31. Wayne continually threatens to take Patrick's truck away from him, if he doesn't spend the weekends with him, which is cruel and mean. The truck is titled in the name of the church, so Wayne controls that as he does the people there. He always tries to be in control.
- 32. On June 24, 2001, Patrick did not go to Wayne's church. He was recuperating from strep throat and also had to work at 12:00 noon. Wayne called after he realized Patrick missed church. He phoned Patrick, yelled, and showed his temper. He threatened again to take Patrick 's truck. Patrick explained that his boss needed him to work just this once on a Sunday, so Patrick said he would. Wayne showed himself, and phoned Patrick's boss and embarrassed Patrick. I want to take our children to a normal established church with me when they are with me on the weekends, but Wayne threatens me or the children if they don't go to his church. I am tired of living with his threats.
- 33. Wayne goes off on strange tangents sometimes. He invited a speaker recently to the

- church right before I stopped going. This man said "gold dust" was falling on the people in the congregation and there was glitter found on the platform. I think my children deserve the opportunity to visit an established, well-known traditional church with a pastor who is educated in a seminary.
- 34. Wayne had offered me \$700.00 a month and use of a car for three years if I would agree to him having primary custody of our children. I could and will not agree to that. I have always been the primary caretaker of our children, and I need to have the main say-so in their lives. Wayne is smart and helps them study, but he gets off on weird things like "gold dust" falling and I'm afraid he might continue to do strange things. Because Wayne goes off on "weird things", he attracts strange people. A few months ago, one of the strange people whose family members had visited Wayne's church went out and bought a gun and was looking for Wayne to kill him. Wayne even warned me to lock my doors at home. I was terrified, and I fear for my children's safety in his custody. Wayne has quite a few enemies. One of the writers of The Sun News, David Wren, wrote an article about Wayne and referred to the misconduct charges that were brought up against him in Florence. The children and I again felt embarrassed and humiliated over this
- 35. Everyone who works for Wayne is intimidated by him. Wayne is so manipulative. He is unstable and I don't want him to ever lose his temper again with Patrick, and God forbid he ever hit my daughter. She and my son want to live with me, and I believe their best interest would be served by custody being granted to me.
- 36. I had no choice but to quit school and get a job when Wayne moved out and left us. I make \$7.25 an hour and drive over 40 miles a day to and from my job. Lacy goes to the church's summer camp, and Wayne keeps her until I get off work.
- 37. I had to borrow the funds from my sister to pay my attorney retainer fee of \$2,500.00.
  I cannot support my children and myself on my minimal salary. I am willing to move out of the marital residence to a less expensive place, but I shall need financial

assistance from my husband by way of child and spousal support.

38. I seek an order of this Court granting me custody of my children, requiring my husband to pay child support pursuant to the South Carolina Department of Social Services Child Support Guidelines, use and possession of the vehicle in my possession, spousal support, and attorney fees and costs.





To Whom It May Concern:

I have known Dr. Wayne Miller and Susan Miller for over three years. I am a studen Cathedral Bible College as well as a teacher at Cathedral Hall Academy. I am also a member of Cathedral Church. Over the past few years, I have been close to the entire Miller family. We have been personal friends as well as co-workers and I have also had Lacy Miller as my student at the Academy. Because of my relationship both in the church and academy, I see the Miller family on a daily basis. About two years ago Susan Miller and I became very close friends. Lacy was in my classroom and I saw Susan daily-before and after school. Then our relationship expanded to lunches out, dinners, picnics, shopping etc. The Millers' have entertained my family and even my out of town relatives on a regular basis. As my friendship with Susan grew from teacher-parent relationship, and church member, Susan and I spent an increasing amount of time together tanning, exercising, eating out, etc. Our children have spent the night at each other's homes and my daughter, Tabitha, would baby-sit Lacy while we went out. Susan has always maintained a distant relationship with church members as well as employees of the ministry. I had thought the reason was she was a person who did not want to have others involved in their personal lives because of her position in the ministry as a pastor's wife. I later came to find out that most of Susan's reluctance to associate on a personal level was because she did not want anyone to know the real Susan. Susan was living a life of constant cover up. Her life was steeped in deception and lying. As our relationship began to develop I became aware of the fact that Susan was obsessed with her computer and she had become obsessed with the Internet and e-mail. For example, we could never leave the house or come into the house without Susan checking the e-mail. Even when Susan would stop by the office to see me or to pick up Lacy, she would jump on the computer to check her e-mail. I confronted her about her obsession with the Internet and in her own words she told me that her computer "was her life line and her only access to the outside world". I know many people, including myself, who use a computer for business and personal use and do not share this obsessive behavior.

Susan began to tell me on a daily basis how she would stay up all night and chat on the Internet. At first, she said she just talked to friends, but later disclosed to me that she had numerous male friends whom she was involved with in daily Internet conversation. She even told me that she was deeply in love with one man from Texas named Matt. Susan had carried a picture of him in her purse, which she showed me.

Susan also disclosed to me about Rich, who lived in Connecticut. He called her everyday and she called him. She had a private phone line put in upstairs that he used to call her on. He sent her calling cards for her to use to call him so her long distance wouldn't be traceable on the phone bill.

Susan would leave church services and other functions to race home for Rich's telephone calls because she knew Dr. Miller would be preoccupied with business or entertaining guests. On most occasions, this caused great embarrassment for Dr. Miller-having his wife showing up late and leaving early.

I really became concerned about Susan's obsession and tried to confront her on many occasions and would tell her that she was taking risks for her marriage, her husband's ministry, and her family. Every time I would discuss this with Susan she would tell me to just hush and be her friend regardless. I told Susan the things she was doing was very deceptive and that if she was unhappy in her marriage to leave Dr. Miller and then pursue her other relationships. I told her that it was unfair to Dr. Miller to be so deceptive and I thought that Susan was crazy to have all this going on in their home behind his back. Susan started to shop at lingerie stores frequently when we would go shopping. She started telling me that she was purchasing lingerie, panties and bras for an upcoming affair she was planning with Rich from Connecticut.

One day she disclosed to me that she had a Post Office Box that Dr. Miller did not know about. One day, on our way to her house, she stopped at the Surfside Post Office. I went in with Susan and she had received a large package from Rich. It contained a CD player and CDs for her to listen to as she tanned at the tanning bed, Victoria's Secret perfume and toiletries, and a pair of panties that she said he wanted her to wear and mail back without washing. There was also a worn, dirty T-shirt of Rich's that she said he wore so she could see what he smelled like and so she could sleep in it. He also sent Godiva Chocolates and animal crackers-her favorite cookies and chocolates. Each package was wrapped and he had written messages such as "I love you", "my baby" etc. She told me that they exchanged gifts often. I do not know how long their relationship lasted. Near the beginning of the school year (August 2000), Dr. Miller had to make a trip to Florida. Susan told me that when he went out of town Rich was flying down here to see her. I was very concerned for Susan's safety when she told me that they would stay together at the Holiday Inn Express in Murrells Inlet. Susan had never met him before and I told her that he could be crazy and harm her, that it wasn't safe to meet a total stranger in a motel room. Susan was insistent that she didn't care and she was meeting him and having sex with him and she couldn't wait. He arrived to meet her. Susan met with him and stayed at the motel with him. Tabitha had spent time with Lacy that weekend and Susan called me from the motel and when she was with him to check on the children. She also told me that they had sex and went into detail about him performing oral sex on her for hours at a time. She said she was disappointed in his looks but said he was a nice person but not what she had expected. I know that when he left that Sunday, Susan left church early to try and see him off at the airport. After his flight left, she told me she missed him.

I had started dating a man named Rick who Dr. Miller and Susan had met when he had attended a couple of church services and then at their home for coffee when my mother and sister were visiting from out of state. Once, Rick had taken Susan and I to lunch one afternoon in the summer. During lunch, Susan disclosed to Rick her desire to leave Dr. Miller and how she wanted a relationship with another man. Susan had heard that Rick had a background in psychology and that he was an attentive listener. My relationship with Rick was very short. I was not interested in pursuing a long-term relationship with him. Susan reported to me that he had called her several times about our relationship ending so abruptly and I asked her to tell him not to call anymore. Apparently, their conversations continued. Late one evening Rick called her cell phone when I was in the

car with her. On another occasion, he called her house phone when I was there. When I confronted Susan about their relationship, she admitted she felt a need to talk to Rick and she admitted that they still talked. She said they had become really good friends. Months later she told me their relationship was over and that he had moved out of town.

Susan made it clear to me that she was having a sexual affair with Mr. Rick Bethke. She came to me at work and threatened to try to have me fired if I told her husband anything about what she was doing. She came and apologized to me for having the affair since Mr. Bethke had been my friend and I had brought him to church for spiritual growth and not for adultery with her. Her sister, Ms. Linda Cirsenka, according to Mrs. Miller, provided her with her condo in N. Myrtle Beach for a place to have their affairs.

The relationship between Susan and I was became increasingly uncomfortable because Susan was so pre-occupied with the Internet, lingerie and other men. Eventually I told Susan I didn't want to know anything more about her deceptive actions. I sought counsel from a friend who is an attorney who advised me to begin to cut ties with Susan. I had become part of a precarious situation and my only way out was to not be personally involved any longer with Susan Miller.

Her actions since I have known her has made it very apparent that she is not concerned about the wellbeing of her children. For example, I saw Susan manipulate the children into seeing things only her way. She would tell them not to work, to let their father pay for things. Also, I had seen her go into his office drawer and take checks. Susan also has a major problem in getting the children up and dressed for school. I have served as Academy secretary, headmaster assistant, and assistant principal. Lacy was frequently late to class and I have on countless occasions had to call the home and the children to tell them to get ready and get to school. When I served as camp director and their son, Patrick worked as a junior counselor, I would have to call Patrick daily to make him come to work. Also, Susan allowed Patrick privileges in order to keep him quiet about the men she was involved with.

In conclusion, having known the family for many years, I feel as though the children will be best served by allowing them to stay with their father full-time.
