

Narrative: You were involved with a rumor about you and Cpl [redacted] s wife. The original rumor was that you had sexual intercourse with her. I had a discussion with Ptl [redacted] Cpl [redacted] and you and thought the matter had been resolved. The rumor then came back to me stating you were also seen kissing and dancing with her the same night you allegedly sleep with her and I knew about the situation and took no action. I called you back in and advised you that it was an ongoing investigation and not to discuss the situation with anyone. I was in the process of investigating the circumstances and found out that you had talked to Cpl [redacted] about the situation and received information from his wife concerning the investigation. Ptl [redacted] also approached Lt [redacted] stating he didn't want to work with you anymore because he knew you were upset with him. Ptl [redacted] also felt that you were intimidating him. I called you in again and you admitted to talking to Cpl [redacted] because you were trying to resolve the matter. I offered you a polygraph to clear up the situation and you refused. This entire situation reflects negatively, not only on you but the entire department. These actions directly violates Walterboro Police Department (WPD) Policy and Procedures and the City of Walterboro Personnel Administrative Guidelines.

Your actions are a violation of WPD Policy and Procedure 03-001 and 94-013 that outlines unbecoming conduct, moral conduct, insubordination, use of a polygraph, rumors, and lawful orders. The City of Walterboro Personnel Administrative Guidelines even uses insubordination, conduct which tends to undermine authority, failure to carry out instructions, interference with the work of others, and coercing or intimidating fellow employees as examples of conduct warranting disciplinary action. You are hereby terminated as an employee of the Walterboro Police Department.
