ON 3-7-2017 AT APPROX 2300 HRS I, OFC FLETCHER, RESPONDED TO 2 [REDACTED] COLDWATER CIR IN THE MB SECTION OF HORRY COUNTY IN REFERENCE TO HARASSING PHONE MESSAGES.

UPON ARRIVAL CONTACT WAS MADE WITH THE COMPLAINANT (E1). E1 ADVISED THAT [REDACTED] SENT HIM THREATENING MESSAGES. E1 ADVISED THAT HE HAS ON GOING ISSUES WITH [REDACTED] AND EX WIFE AND [REDACTED] REGULARLY MESSAGES HIM THREATENING THINGS. THE MESSAGES WERE REVIEWED AND [REDACTED] (E2) SENT MESSAGES REGARDING [REDACTED] PAYING [REDACTED] THE MONEY HE OWES HER OR E2 WAS GOING TO BEAT UP E1. E1 ADVISED THESE ISSUES ARE ON GOING AND THAT E1 HAS ALSO

DAMAGED HIS VEHICLE IN THE PAST. E1 ADVISED THAT E2 HAS THREATENED HIM OVER THE PHONE SEVERAL TIMES OVER A TWO YEAR PERIOD BUT HAS NEVER ACTED ON THE THREATS. THE THREATS WERE DEEMED EMPTY IN NATURE. E1 ADVISED THAT HE WANTED THE INCIDENT DOCUMENT AND WANTED LE TO CONTACT [REDACTED] AND HAVE A WORD WITH HIM.

CONTACT WAS MADE WITH E2 AND [REDACTED] AT 3 [REDACTED] FRESHWATER CT. E2 ADVISED THAT HE HAD THREATENED [REDACTED] BUT WAS JUST MAD AT HIM AND HAD NO INTENTIONS OF CARRYING OUT SAID THREATS. E2 AND [REDACTED] WERE ADVISED TO CEASE CONTACT WITH E1 IF THE CONTACT WAS GOING TO CAUSE ADDITIONAL ISSUES. NOTHING FURTHER.

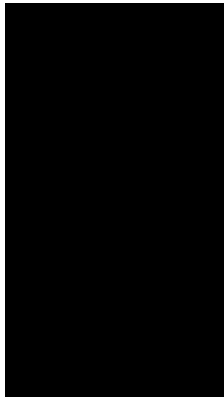
