NARRATIVE

ON 05/01/2024, AT APPROXIMATELY 1446 HOURS, I PFC MINETT WAS DISPATCHED TO 803 HOWARD AVE IN REFERENCE TO A POSSIBLE HARASSMENT.

WHEN ARRIVING ON SCENE THE COMPLAINANT ADVISED THAT SHE IS ONE OF THE PASTORS AT THE CHURCH. THE CHURCH AND THE COMPLAINANT HAVE BEEN RECEIVING MULTIPLE FACEBOOK MESSAGES, EMAILS SINCE THE PASSING OF PASTOR JOHN PAULS WIFE.

R/O WAS SHOWN MUTLIPLE POSTS AND MESSAGES BEING SENT TO THE CHURCH. NO DIRECT THREATS OF VIOLENCE SEEN. THE POST ARE JUST VERY VAGUE ABOUT CANCELING AND ENDING THE CHURCH FOR ITS "LIES". CERTAIN FACEBOOK GROUPS AND TIK TOKS HAVE BEEN DISPERSING THE STORIES ABOUT THE CHURCH IN HOPES TO "END THEM". NO DIRECT PERSON IS BEING HARASSED. PASTOR JOHN-PAUL WAS NOT ON SCENE TO MEET WITH OFFICERS.

ALL THE INFORMATION GATHERED WAS PASSED ONTO DIRECT SUPERVISION. AT THIS TIME THERE IS NO HARASSMENT.
