did within this county and state on or about 11/6/2024 violate the criminal laws of the

in the following particulars:

DESCRIPTION OF OFFENSE: Assault / Assault & Battery 3rd degree

I further state that there is probable cause to believe that the defendant named above did commit
the crime set forth and that probable cause is based on the following facts:

On 11/6/2024, officers with the Myrtle Beach Police Department responded to the area of 743 Hemlock Ave, a location in the city
limits of Myrtle Beach, in reference to a possible assault. During the course of protesting the location, the victim crossed the street to
approach the defendant. The victim stated "Here Kitty Kitty" to the defendant. The defendant turned around and approached the
victim. The defendant got into the victims face and put his phone up as if he was recording her. During this action, the defendant is
said to have tapped the brim of the victims baseball cap. The defendant then turns around walks away from the victim. Video of the
incident does not appear to show the assault, although directly after the possible assault, the victim can be heard yelling on video
"Don't you touch me". A witness stated that she observed the defendant hit the victims hat twice.
