NARRATIVE

ON 06/28/2024, AT AROUND 2207 HOURS, THE COMPLAINANT ARRIVED AT THE MYRTLE BEACH POLICE DEPARTMENT, LOCATED AT 1101 NORTH OAK STREET, TO REPORT A LIBELOUS WEBSITE REGARDING HIM AND HIS CHURCH.

R/O SPOKE WITH THE COMPLAINANT WHO PROVIDED R/O WITH NAME OF THIS WEBSITE, SOLIDROCKMYRTLE.COM". THE WEBSITE DISPLAYED INFORMATION REGARDING SOLID ROCK CHURCH IN MARKET COMMON AND THE COMPLAINANT HIMSELF. THE WEBSITE READS AS IF THE COMPLAINANT HIMSELF WROTE IT. THE COMPLAINANT EXPLAINED IT IS NOT HIS WEBSITE, NOR DID HE WRITE IT. THE WEBSITE CALLS THE COMPLAINANT A MURDERER, SEX TRAFFICKER, ABUSER AND A MONEY LAUNDERER . IT ALSO STATED THAT SOLID ROCK CHURCH IN MARKET COMMON IS A COVER UP FOR EMEZZLEMENT

THE COMPLAINANT WANTED A REPORT TO BE COMPLETED. THIS IS AN ACTIVE INVESTIGATION.
