My wife text her son asking him to NOT text her and he did anyway.


It is my heart that Heather Wilson and her son are the main cause of all that has happened.


We have witnesses of Heather Wilson in a restaurant openly saying horrible things about my wife just a few days ago.


We are working on a civil suit as well.





## Captain Strickland,


