On September 5th, 2024 the plaintiff filed a COMPLAINT AND MOTION FOR A RESTRAINING ORDER at the Myrtle Beach Magistrate Office. The defendant was personally served notice of said complaint by the Horry County Sheriff's Office on September 25th, 2024. On October 7th, 2024 all parties appeared at the Myrtle Beach Magistrate Office represented by council. The Court received all sworn testimony and evidence offered.

The plaintiff stated his wife killed herself, and since then he has been followed and harassed by the defendant creating a dangerous environment that has left he and his young children feeling scared and afraid. The plaintiff continued by stating he does not know the defendant, and has told him multiple times to leave he and his family alone. The plaintiff stated the defendant will wait outside of his residence at all hours, follow him to work, follow him to church and video him while hiding in shrubbery. The plaintiff stated the defendant has posted on social media pictures of the plaintiff's vehicle, the plaintiff's vehicle license plate, the plaintiff's residence and work place. The plaintiff stated all the targeted, unwanted negative social media attention has caused his children to be bullied at school, and caused them to suffer mental and emotional distress. The plaintiff further stated the defendant saw him driving to the mall, the defendant performed a U-turn and followed him to the Mall. The plaintiff stated once at the mall he and the defendant had a conversation. The plaintiff stated he asked the defendant to leave he and his family alone, and stop following him. The plaintiff stated the defendant replied, he would stop following him, stop video recording him, stop posting about him on social media and take down all of his old social media post only if the plaintiff agreed to retract a complaint the plaintiff filed against the defendant, or he would bury him. The plaintiff stated he refused and the defendants stalking and harassment continued. The plaintiff concluded by stating the defendant went on social media and stated he lived so close to the plaintiff he could shoot him.

CROSS OF PLAINTIFF:

Attorney O'Neil asked the plaintiff if he filed the RESTAINING ORDER? Which the plaintiff answered yes.

Attorney O'Neil asked if there were 3 incidents? The plaintiff answered more then three.

Attorney O'Neil asked if the plaintiff called the police and are there any reports? The plaintiff answered he did call the police and they refused to do a report.

Attorney O'Neil asked if knew the defendant is part of the media and his actions are protected by the 1st Amendment? The plaintiff answered he did not agree.

Attorney O'Neil asked if the plaintiff liked speaking to the media? The plaintiff stated, yes sometimes it can be a good thing.

Attorney O'Neil asked if the plaintiff was afraid of the defendant? The plaintiff stated yes, he follows me, lurks in bushes around my house and work.

Attorney O'Neil asked has the defendant ever threatened you? And have you told him to leave you alone? The plaintiff answered yes, I have asked him to leave me alone and he has threatened me by saying he lives close enough to me he could shoot me.

REDIRECT:

Attorney Long asked the plaintiff if any real media behaves like the defendant or uses the same methods? The plaintiff answered no.

The defendant stated he is part of the media and that covering events is his occupation. The defendant stated he is allowed into the Country Music Festival as media to cover the event. The defendant stated he is providing a public service by reporting on the plaintiff, because he is a public figure that people have interest in knowing about him. The defendant stated he has never made a threat or attempted to cause any harm to the plaintiff. The defendant stated the plaintiff has never told him to leave him alone, and the plaintiff gave him permission to post videos about him on social media. The defendant stated that he has never followed the plaintiff, he just happens to see him out and about. The defendant stated he did tell the plaintiff he would leave him alone, remove all social media post and stop any further post only if the plaintiff agrees to retract a complaint he filed against the defendant with a social media platform. The defendant stated he wanted the plaintiff to retract the complaint so he could get paid by the social media platform company for his postings.

CROSS OF DEFENDANT:

The defendant was asked by attorney Long if he has ever followed the plaintiff? The defendant answered stating he has never followed anyone to include the plaintiff.

The defendant was asked by attorney Long again about following the plaintiff, and the defendant changed his answer when confronted with evidence of him following the plaintiff. The defendant answered I did follow the plaintiff once.

The defendant was asked by attorney Long if he videoed the plaintiffs house, the plaintiff's mom and post it on social media? The defendant answered yes.

The defendant was asked by attorney Long if he is employed by any media company or is he paid any money for his service. The defendant answered he does not work for any media outlet, and receives no pay for his actions. The defendant continued stating he only covers the protest at the plaintiff's church, that he does not follow him around.

Redirect:

Attorney O'Neil asked the defendant if he reports on criminal activity, do you video this activity and do you provide a service to the public. The defendant answered, yes to all.


FINDING OF FACT BY THE COURT:

- 1) The plaintiff and his family had a tragic event happen involving his wife that was reported on multiple recognized news outlets.
- 2) The plaintiff was investigated by law enforcement and determined to have no involvement in his wife's suicide.
- 3) The defendant has targeted the plaintiff and has performed multiple unreasonable intrusions into the private life of the plaintiff that serves no other legitimate purpose.
- 4) The defendant's actions would cause any reasonable person to suffer mental and emotional distress.
- 5) The Court found the defendant's testimony not to be credible, and disingenuous.
- 6) The defendant admitted to attempting to extort the plaintiff.
- 7) The Court was not presented nor convinced the defendant should be recognized as any form of media or news outlet that serves the public.

In conclusion, the Court fully recognizes and respects the First Amendment of The United States Constitution. However, when a person engages in such unreasonable intrusions into the private life of a targeted person who is not even a suspect in a crime, and also attempts to obtain something from that targeted person by means of extortion, the Court believes the defendant has pierced any protections the First Amendment may have provided.

The Court found by the preponderance of the evidence and testimony presented and issued a RESTRAINING ORDER against the defendant.


The Defendant hereby appeals from the judgment of the Myrtle Beach Magistrate's Court in the above captioned restraining order to the Horry County Court of Common Pleas.

This Notice of Appeal is made subsequent to personal notice of the restraining order which was received on the 7th day of October, 2024. (See the attached Summons and Complaint marked as Exhibit "A" and Restraining Order marked as Exhibit "B").

The Defendant/Appellant's exceptions to the judgment of the magistrate are as follows:

The Plaintiff failed to prove by a preponderance of the evidence that he is entitled to the issuance of a restraining order. The Defendant/Appellant contends the Court erred as fact finder and erred as a matter of law in granting the restraining order in that the statutory elements required to issue the restraining order were not met nor proven by the preponderance of evidence in this matter. Defendant/Appellant further appeals contending that his rights under the South Carolina & United States Constitutions in regards to his freedom of speech and as a member of the press were infringed upon with the issuance of the restraining order in question as the complained about conduct is constitutionally protected.

Therefore the Appellant asks that the Court of Common Pleas hear his Appeal and rescind the Restraining Order.

VIOLATION OF THIS ORDER IS A CRIMINAL OFFENSE PUNISHABLE BY THIRTY DAYS IN JAIL, A FINE OF FIVE HUNDRED DOLLARS, OR BOTH, AND IS IN ADDITION TO OTHER CRIMINAL PENALTIES WHICH MAY RESULT FROM SUCH ACTION.
