ON 5/20/2015, I RESPONDED TO THE ABOVE ADDRESS AS A BACK-UP DEPUTY. UPON MY ARRIVAL, I EXITED MY POLICE UNIT, ROUNDED THE CORNER OF THE BUILDING AND MADE CONTACT WITH A WHITE MALE; LATER IDENTIFIED AS MICHAEL COLUCCI.

MR. COLUCCI WAS CRYING AND EXTREMELY DISTRAUGHT. I OBSERVED BLOOD COMING FROM MR. COLUCCI'S MOUTH, AT WHICH TIME I PUT ON MY NITREX GLOVES. I INFORMED MR. COLUCCI HE WAS BLEEDING FROM HIS MOUTH. MR. COLUCCI STATED TO ME "IT WAS FROM ME DOING CPR ON MY WIFE." I ASKED MR. COLUCCI WHO HE WAS. MR. COLUCCI STATED HE WAS THE HUSBAND. MR. COLUCCI BEGAN YELLING, "MY WIFE, MY, WIFE, MY WIFE, SHE'S GONE." I INSTRUCTED MR. COLUCCI TO COME WITH ME AND THAT HE DIDN'T NEED TO SEE HIS WIFE LAYING THERE.

MR. COLUCCI TURNED AWAY FROM ME, SAT DOWN IN HIS CAR AND STARTED IT. I INSTRUCTED MR. COLUCCI TO TURN THE CAR OFF AND TO COME WITH ME.

MR. COLUCCI EXITED HIS CAR AND FOLLOWED ME AND A BERKELEY COUNTY, EMS FEMALE AROUND THE CORNER OF THE BUILDING. ONCE AROUND THE CORNER, THE EMS PERSONNEL INFORMED ME THAT SHE KNEW MR. COLUCCI. THE EMS PERSONNEL AND I INSTRUCTED MR. COLUCCI TO SIT DOWN. AS HE DID, THE EMS PERSONNEL ASKED MR. COLUCCI WHAT HAPPENED.

MR. COLUCCI STATED HE AND HIS WIFE HAD JUST COME BACK FROM A CEMETERY AFTER VISITING THE GRAVE SITE OF THE VICTIM'S PRIOR HUSBAND AND AFTER LEAVING, HIS WIFE STATED THEY NEEDED TO GO BY THE WAREHOUSE. MR. COLUCCI SAID ONCE AT THE WAREHOUSE, HE STAYED IN THEIR CAR, GAVE THE WAREHOUSE KEYS TO HIS WIFE AND SHE EXITED THEIR VEHICLE.

MR. COLUCCI STATES HE NOTICED HIS WIFE STANDING NEXT TO THE FENCE FOR A FEW MINUTES, BUT WAS NOT MOVING. MR. COLUCCI STATES HE EXITED HIS VEHICLE TO CHECK ON HIS WIFE, BUT GOT BACK IN THE VEHICLE WHEN HE NOTICED HER MOVE. MR. COLUCCI STATES AFTER A FEW MORE MINUTES, HE NOTICED HIS WIFE WASN'T MOVING AGAIN; SO HE EXITED HIS CAR TO CHECK ON HER AND THAT'S WHEN HE SEEN HER HANGING FROM THE FENCE.

CPL WELLS INSTRUCTED ME TO PLACE MR. COLUCCI IN THE BACK SEAT OF MY PATROL CAR AND TO LET NO ONE SPEAK TO HIM.

I WAS INSTRUCTED BY CAPT. SHULER TO TRANSPORT MR. COLUCCI TO GOOSE CREEK POLICE DEPARTMENT, WHERE I TURNED HIM OVER TO LT. KOKINDA FOR PROCESSING.
