On Saturday, Feb 23 my husband & I hosted an oyster roast for friends & their families. It began around 6:00 pm & everyone left beginning around 11:00 pm with our last guest helping us clean up & then they left around 12:00. This was a supper with oysters, crab boil, & appetizers. No alcohol was served at the event. We provided bottled water & lemonade. Guests came by boat & car & no guests brought coolers out of their vehicles. The adults went to their car if they were grabbing a drink. The kids involved in the accident came by boat from Cheechossee around 7:30-7:45 and docked at our neighbor's dock because there was a boat on our dock. Wiley Altman had a white claw in her hand but threw it away. (Her parents were at the dinner) No kids were seen drinking at our house nor were they provided alcohol. While at our house they ate, played corn hole, sat by the fire, & played basketball. I spoke with the kids & none appeared intoxicated or gave any concern for being on the boat. Paul is very familiar with boats & navigating water. The kids left around 11:15-11:30 after playing a game of "horse". (Morgan made a beautiful shot) I offered to let them stay at the house because the temperature dropped & told them they were going to "freeze your butts off" not for any
