On February 28, 2023, at approximately 9:18 p.m., Special Agent (S/A) Shakera Shider conducted an audio/video recorded interview with [REDACTED]. [REDACTED] was interviewed because she was allegedly told information about the murder trial of Richard Alexander "Alex" Murdaugh by a member of the jury. provided the following information: She had her refrigerator replaced on a Saturday in February of 2023. *Agent's Note:* [REDACTED] *did not remember the exact date the refrigerator was replaced.* Her landlords Myra Crosby and Timmy Crosby brought the replacement refrigerator to their home along with their nephew [REDACTED]. While inside the home everyone was talking about their jobs. Myra Crosby stated that she has been working at the "Monkey Hospital." *Agent's Note:* [REDACTED] *did not state if Myra Crosby described what she meant by "Monkey Hospital".* Myra Crosby also stated, "I have not been to work in the last few weeks because I got picked for that damn trial." *Agent's Note:* *Myra Crosby was referring to the Murdaugh trial.* [REDACTED] stated Myra Crosby liked to gossip. Initially [REDACTED] stated that Myra Crosby did not disclose any other information about the trial after she informed them that she was a juror. Later during the interview [REDACTED] disclosed that Myra Crosby stated, "As of right now there was no evidence beyond a reasonable doubt that would make her think he was guilty. But I'm not supposed to be talking about anything."

[REDACTED] stated she did not know Myra Crosby was a juror prior to the conversation, but she believed Myra Crosby was saying everything in a jokingly manner. She has known and been friends with Myra Crosby since 2017. She has only discussed this matter with her fiancé [REDACTED]. She does not know if Myra had disclosed this information with anyone else.
