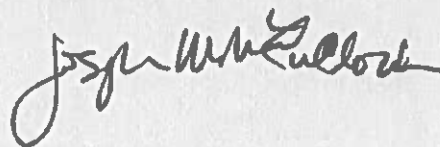

**PETITIONER'S RESPONSE TO THE
STATE'S MOTION TO UNSEAL AND
RESPONSE TO MOTIONS TO UNSEAL
AND TO MODIFY PROTECTIVE ORDER**

On May 20, 2026, Petitioner filed her motion requesting the Court review certain Protective Orders in the captioned matter and "lift the Protective Orders" to the extent necessary to allow release of the jury tampering investigations of Rebecca Hill. Petitioner now responds to the July 3, 2026 filing of the Attorney General's Office, in which the Attorney General does not oppose lifting the Protectives Orders, however several aspects of that filing require clarification:

1) Petitioner Myra Crosby, on July 22, 2024, filed a Motion to Unseal the *In-Camera* Proceedings (**Exhibit A**) that resulted in her removal from the Murdaugh murder jury. The Attorney General consented to Petitioner's request to unseal at that time, and the Court unsealed the *in-camera* proceedings to the limited extent of permitting Petitioner and her counsel access, but prohibited further dissemination. The purposes for which Petitioner sought access were then satisfied, and Petitioner has not sought any further unsealing

regarding the in-camera proceedings in part now referenced by the Attorney General in its

recent filing. Upon review of those in-camera materials released to Petitioner, none of those documents appear to relate to the State's jury tampering investigation, which is the purpose of this second Motion.

2) Petitioner served Freedom of Information Act requests (**Exhibit B**) on SLED, the Attorney General, and Eleventh Circuit Solicitor Rick Hubbard (who was tasked with oversight of the Becky Hill jury-tampering investigation); those FOIA requests sought the provision of their closed investigative files. The Attorney General and SLED responded that Justice Jean Toal's 2024 Protective Order, and perhaps previous Court Orders, prohibited release, although the investigation was closed, thereby eliminating any FOIA statutory bar to release.

3) Petitioner then filed her motion to declare that the purposes of that Protective Order have long since been accomplished and requested that the Protective Order be lifted.

PETITIONER'S REQUEST AND POSITION:

The purpose of FOIA is to "make it possible for citizens, or their representatives, to learn and report fully the activities of their public officials..." Petitioner believes that both she and the public are entitled to access the investigative efforts of the State for the purpose of reviewing those materials pertinent to the allegations of jury tampering by Becky Hill, if not others, and to critically evaluate that investigative effort by three separate law enforcement agencies. The announcement by the Solicitor at the Hill sentencing, that "...I don't know that I have enough based on what we have to even get an indictment...we cannot get a conviction because we cannot prove that case beyond a reasonable doubt" (**Exhibit C**) stands as a conundrum when compared to the S.C. Supreme Court opinion reversing the double-murder

convictions and granting a new trial. Open access and critical review are paramount considerations in the evaluation of government action.

The State in its recent filing asserts that substantial redactions are needed to protect the identity and privacy of the jurors, measures that seem unnecessary in light of the prior open-court testimony of those jurors, the participation of members of the jury panel in traveling to New York to appear on an NBC television news show, and the participation of jurors in recent documentaries (most recently Netflix). Petitioner concurs with any necessary redactions but believes this "need" perceived by the State should not hinder or delay this Court's consideration of Petitioner's request, nor the unsealing of the investigative materials and their provision to Petitioner.

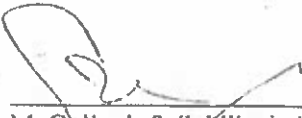

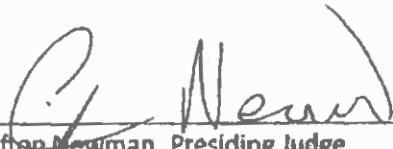

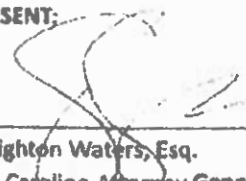
